Code of Conduct

1. The use of drugs, tobacco, alcohol, fireworks, matches, cigarette lighters, or items that would endanger people, pets, wildlife, or property are strictly prohibited.
2. Clothing should be appropriate. This prohibits short shorts, tank tops, baggy pants, bikinis, and any reference to tobacco or alcohol products including insignias or advertisements. (Dance Track will have a separate dress code-to be sent out upon enrollment)
3. Language and behavior should exemplify Christian values.
4. Participants are expected to respect the rights and property of others. Neither vandalism nor stealing will be tolerated. Financial obligations that result from such behavior will be the sole responsibility of the youth and his/her family.
5. This event is an overnight event. Males and females are not allowed to be in each others cabin areas without a chaperone.
6. No participants are permitted to leave the premises without the expressed permission of a SWIFT or Illuminate! leader.
7. Personal electronic devices are permitted but may be collected by camp leaders if they become a distraction.
8. Food and drinks are only to be consumed in designated areas.
9. No participants are allowed to ride in a car with another participant to, from, or during an event unless expressed written permission has been given a parent/guardian to SWIFT or Illuminate Staff and personnel.

I have read the foregoing and understand the Code of Conduct for participants and will abide by them. In addition, I will abide by all directions given me by the SWIFT and Illuminate! Creative Arts Studio leaders and staff. I will dress appropriately and modestly, as outlined above. I also understand and agree that my parents or guardians will be notified at the time of any infraction requiring my dismissal from the event and that I will be sent home at the expense of my parents or guardians. These infractions include possession of drugs, alcohol or tobacco products, engaging in any offensive, illegal or unchristian conduct, or refusing to follow the directions of SWIFT and/or Illuminate! staff, leaders, or volunteers.
